Overview

SIPAG-NY is hosting their annual basketball summer league at the Academy of Saint Dorothy in Staten Island , New York. This League will start on 6/23 and will conclude on 8/22. This document helps to codify the rules so officials and staff can stay consistent throughout the duration of the league. We want to ensure that everyone has a pleasant experience. If any questions please ask our leaders Aaron Sibal (Crew Chief Official) and Eder Miranda (President, SIPAG-NY).

Goals

1. Ensure a safe, competitive environment for everyone to enjoy the game that we all love and enjoy.
2. Avoid injuries. Keep players, officials, fans and staff as safe as possible.
3. Staff and Officials may exercise their authority to maintain the well being of the game.
4. Have Fun! We want everyone to be professional but still enjoy the experience!

Rules & Regulations

*Officials: please adhere to CYO/IAABO rules and regulations. It covers what we're looking for in our games. We'll be working with a wide age-range of kids so use your best judgment. As much as we want everyone to compete, we also want the players to learn and parents to enjoy it. Please help guide the kids and even parents in the right direction, discipline if necessary.

*Staff: Rotating staff members must be briefed and or taught BEFORE the game starts on how to utilize score board and official books. Minimum one book is necessary prior to the game. Staff will be assisted by senior members and will be on standby in case of confusion.

Players, Coaches, Parents have to respect the game and the officials/staff. They must behave in an orderly conduct or are subject to be THROWN OUT and/or DISQUALIFIED. NO EXCEPTIONS. Staff and Officials use your best judgment. (Cheering/Banter is encouraged but if any derogatory statements or misconduct happens, Officials/ Staff please exercise your authority. Staff must uphold officials in their decision and vice versa.)

All players must have matching jerseys / reversible. If NOT, it will result in a technical foul and is subject to two free throws prior to the start of the game.

20 minute halves RUNNING clock ; will NOT stop on free throws.

Last 2 minutes the clock will stop for BOTH halves in Divisions 2 and 3. Clock will stop only in second half for Division 1.

Two 30 second timeouts for the duration of the game

One time out for both teams if overtime is necessary

2 minute overtime. Clock stops at the 1 minute mark

If 20 points lead, NO PRESS. If constant offenders, delay of game - technical foul. Officials use best judgment.

5 maximum player fouls ; if the team is short, the fouled out player is ABLE to play, however If the fouled out player commits another foul, he is subject to a technical foul and the opposing team is awarded 1 free throw. OFFICIALS IT DOES NOT SWITCH POSSESSION. MUST RETAIN PREVIOUS POSSESSION. (Worst case scenario if it's an offensive foul, the defending team is awarded the possession. (Player Cannot be thrown out) .

2 Technicals before player or coach has to sit out. (if player and/or coach exceeds 2 technicals fouls s/he is subject to exit their team bench)

God forbid an altercation/ fight breaks out, Staff and Officials, DO NOT INTERFERE, OFFICIALS YOU'RE LIABLE, these are kids! Please let Senior staff handle it. Game is subject to the severity of the incident. Please contact Aaron or Eder for further course of action.

Official's Uniform

Officials are subject to full uniform. Referee shirt, Black shorts, Black Sneakers. Pants are not required. We are subject to be in pictures and will take pictures to be posted on SIPAG-NY and for their social media platforms @SipagNY
